In this spring issue of our *Off-Campus Bulletin*, I wanted to brief you on some of the initiatives your Board of Directors has taken on behalf of the Retirement Association. The board has been busy.

In January, we directed a letter to VP Leroy Morishita asking for help in resolving two issues which have been thorns in the association's side for years. We want to gain access to information about those who are retiring each year from our campus, both faculty and staff, so that we can invite them to join the RA. At present, ERFA (our state organization) seems to know more about our campus retirees than we do. Secondly, we ask the VP to allow staff retirees, like emeritus faculty, to retain their SFSU email accounts after retirement, if they wish to do so. At the time of this writing, we are waiting for responses to these requests.

In February, our entire board, along with representatives from the University Women's Association and the Friends of the Library, met with the new VP for Advancement, Robert Nava, to discuss the 2% annual management fee recently imposed on endowment accounts by the Foundation. As the three of us (UWA, Friends, and RA) are strictly VOLUNTEER fund-raising organizations, we asked that this annual charge be waived for the three groups. Mr. Nava agreed to look into the matter and get back to us shortly. We remain optimistic that the administration will respond positively to our requests.

In addition to these issues, the board has completed an updating of the membership list and has this past week published the 2011 Directory. You should have received your copy in the mail. A very special thanks to Kay McGough for spearheading this time-consuming effort. Those who have not paid their membership dues recently have been dropped. We hope you will find the new directory easy to read and very useful in keeping in touch with your colleagues.

Our Travel Grant Awards committee (Gene Michaels, Julian Randolph and Dan Buttlaire) will be initiating the application process shortly. As we alternate years between faculty and staff, this year the awards will go to staff members.
