

The SF State Retirement Association & CSU ERFSA

The SF State Retirement Association (the RA) was organized in 1979, at the initiative of Ann Paterson. She also promoted the idea to other colleges in our system, and the Emeritus and Retired Faculty Association was organized as an umbrella group for such organizations in 1985. ERFA became ERFSA, the Emeritus and Retired Faculty and Staff Association with a change to its constitution about ten years ago. Because the RA is the SF State affiliate of ERFSA, RA receives rebates—15%—from dues paid to ERFSA.

The RA and ERFSA may have had a similar origin, and the RA has always been the SF State affiliate of ERFSA, but for reasons lost in the mists of the past, there developed three different types of members at SF State. Some members paid dues only to the RA, some paid dues to both the RA and ERFSA, and some paid only to ERFSA. Those who paid dues to the RA have always received the newsletter since at least 1988, when it was called the Off-Campus Bulletin, and also invitations to social events, especially our spring and fall luncheons but also including other social and cultural gatherings.

Over the past two years, the Board has periodically discussed this situation. In our most recent meeting, we decided that, for the next two years, we would make no distinctions between RA dues-payers and ERFSA dues-payers--that everyone would receive this newsletter and all invitations to all social and cultural events. Some board members worried that this might cause a reduction in our dues income, so the decision will be reviewed in two years.

San Francisco State OLLI

San Francisco State has an active chapter of the Osher Life-Long Learning Institute (OLLI). There are OLLI organizations at colleges and universities all across the country. Some of you may remember in 2012 when Barbro Osher was awarded an honorary degree at commencement. She and Bernard Osher created OLLI as a way to encourage people of our age to remain active—mentally, socially, and physically. Each campus OLLI is funded in part by an endowment from the Bernard Osher Foundation and in part by the chapter members' dues and fees. Each OLLI offers courses of study, but they are classes with no required reading, no tests or essays, and no academic credit—they are learning for the joy of learning.

I enrolled in my first OLLI class shortly after my last semester of teaching, fourteen years ago, and since then I've been taking classes. For the past four years, I've also been offering classes. (It's all the joy of sharing what you know but without blue books and term papers to grade!) The classes are of varying length. Some meet only one time for two or two and a half hours; others meet once a week for six weeks, also in a two or two-and-a-half hour time block; and there are two-week and three-week variations. Some meet in person and others are by Zoom.

OLLI also offers other learning experiences. There's an annual trip to Ashland to the Shakespeare Festival. This year, the highlight will be *Macbeth*. I'm especially looking forward to that play--a year or so ago, I read Ngaio Marsh's last mystery, *Light Thickens*, which is set around a production of *Macbeth*. Reading it sent me to my bookshelf to find my volume of Shakespeare's plays from when I was an undergraduate.

OLLI members can also take part in interest groups, for example, hiking, poetry, adventuring (local field trips), or conversation in either French or German. *Vistas and Byways* literary magazine produces an bi-annual online volume of creative work by OLLI members.

SF State emeriti are involved in the organizational structure of OLLI. Carol Langbort is currently president of the OLLI Council. Rufus Browning recently served as president. I've been on the council the past few years and am on the course development committee.

I think that you all are likely to find something of interest in OLLI, either taking a class, joining an interest group, or teaching a course. You can find out more online: https://olli.sfsu.edu.

Our By-Laws define the duties of these officers this way: The president shall be the chief elected officer of the Association and is subject to the control of the Board of Directors. The president presides at the meetings of the Board of Directors and the membership. The president shall recommend appointments to special committees, subject to ratification by the Board of Directors.

The secretary shall serve as a recording secretary for the annual business meeting and the meetings of the Board of Directors. The secretary shall perform those duties as called upon by the president.

The Board of Directors shall have supervision, control, and direction of the affairs of the Association, its committees and publications; shall determine the policies and procedures; shall actively carry out its purposes; shall supervise the disbursements of its funds; shall recommend bylaws amendments to the membership; shall be responsible for the interpretation of these bylaws; and shall approve the budget.

The board meets four times a year, by zoom, so you don't have to leave home to attend a board meeting.

Special Delivery

Downsizing at a certain age after retirement, one considers leftovers from youthful pursuits. I was a stamp collector. I didn't want to relive that activity, so my wife inspected masses of stuff and donated most of it to charity. She found an odd item: a letter from Dexter Franklin to Corliss Archer in an envelope with a special-delivery stamp postmarked 2 April 1954 but never




opened, with a notice of arrival. She asked, was that a special stamp? No, but it certainly reflected a special event in that year. I had been drafted into the cast of my ninth-grade class play, *Meet Corliss Archer*, at Hayward Junior High School in Springfield, Ohio. The previous

semester, my English teacher, Mrs. Berger, had taught me to orate by dressing me as Abraham Lincoln—she thought that artificially bearded I'd resemble him—and having me re-enact his Gettysburg Address for a school assembly. Corliss should teach me even more tricks that I'd need later in life. The play was based on a book and popular radio/TV serials about teenagers. Mrs. Berger cast me as Corliss's father Harry, like Lincoln a lawyer.



In the play, Corliss's boyfriend Dexter invites her to their school prom by sending her a




special-delivery letter. We needed a prop, an authentic letter. My father provided it. He was the dead-letter clerk at the post office, who processed all undeliverable mail. He put a blank sheet in an envelope with an address like that in the play, and sent it registered to Corliss with a special delivery stamp. That address did not exist in Springfield, so of course the letter eventually came back to him at the post office! He provided it for the play.

Acting in junior-high school certainly taught me delivery techniques that I used throughout my career as a professor, and something else very special: how to handle acute public embarrassment. Not just as Lincoln, but as Harry Archer. At the end of the play, I had to kiss Mrs. Archer, with a flamboyant swooping gesture, front and center. A special delivery for Mrs. Archer, too!

Robert Corrigan 1935 – 2024

In 1988, Robert Corrigan became the twelfth president of San Francisco State. He served in that position for the next twenty-four years, until 2012. For most of us in the Retirement Association, he was president for more than half our time at SF State. He died on July 5 of this year.

Corrigan was the first in his family to graduate from high school. He received his BA from Brown and his MA and PhD from the University of Pennsylvania, in American Civilization. He came to SF State from leading the University of Massachusetts, Boston, where he had been instrumental in bringing to that campus the John F. Kenendy Presidential Library.



During the final years of his SF State presidency, Corrigan's two vice-presidents had both started at SF State in entry-level positions. John Gemello, who served as provost, began as a lecturer in Economics, and Leroy Morishita, who served as administrative vice-president, began in student services.

John Gemello provided these thoughts about Corrigan's service at SF State: "Bob Corrigan came to SF State with the mission of making San Francisco State the leading public urban university in the country. He understood the role of an urban university, bringing a commitment to civic engagement and putting the University at the heart of San Francisco and the Greater Bay Area. He also understood the importance of an engaged faculty. He enthusiastically backed the joint Academic Affairs, Academic Senate, and CFA plan to normalize the "three course load" for faculty as a means to support scholarship efforts of existing faculty and the hundreds of new faculty hired during his presidency."

Leroy Morishita offered this remembrance: "Bob Corrigan and I had some 'battles' early in his tenure but ultimately we both earned each other's respect and admiration. I appreciated the opportunity that I had to work with him in the transformation of the university working together with his cabinet through crises, acquiring adjoining properties, developing a physical master plan, and dealing with the great recession as best as possible." Morishita later served as President of CSU East Bay and as interim president at CSU Los Angeles.







Dennis Beall, 95, Emeritus Professor of Art, died peacefully on September 9, 2024. He was a renowned printmaker, educator, curator, administrator, avid birdwatcher and traveler. Born on March 13, 1929 in Chickasha, Oklahoma and served in the U.S. Navy for three years. While in the Navy he attended the Electronics Material School on Treasure Island and following his service returned to Oklahoma State University. Moving to San Francisco in 1953 he completed a BA and MA in Art at San Francisco State. Serving briefly as registrar at the Oakland Museum of California he became curator of the Achenbach Foundation for Graphic Arts in San Francisco. Joining the Art Department faculty at SFSU in 1965 as an Assistant Professor he was promoted to Associate in 1969 and Professor in 1976, retiring as an Emeritus Professor in 1992. Beall's career included 25 solo exhibitions and participation in over 200 exhibitions internationally. His prints are included at the Victoria and Albert Museum, the Library of Congress, the New York Museum of Modern Art among numerous museums as well as in collections at many colleges and universities. He first married Miriam "Mimi" Robbins in 1958 and they had one son Garm. Years later, after meeting Pamela Conley on a birdwatching trip, they married in 1981. Together they spent many wonderful years chasing birds and traveling. He is survived by his wife Pam, his son Garm, his daughter-in-law Gina Thornburg, and his grandson Taylor Beall. No services are planned.

Jane Bernard-Powers, Professor Emerita and Chair of the Department of Elementary Education from 1990 to 2010, died July 15 at the age of 82.

Irene Bobak, Professor Emerita of Nursing and Dean of Faculty Affairs and Professional Development. Appointed 1991, emerita since 2008. M.S. in Library Science, University of Illinois, Ph.D. in Curriculum, Instruction and Administration, Boston College. Died February 2, age 78.

James G. Edwards, Professor Emeritus in Design and Industry from 1985 to 2009, died June 9 at age 79 in his beloved Thailand where he retired to after 23 years of teaching at SFSU. He then went on to travel with Rick Steve's Tours 26 times. They were both 6'5". Jim was an active member of Epsilon Pi Tau, the International Honorary for Professions in Technology, becoming the Trustee for the Beta Beta Chapter in DAI, now the School of Design, and later as Western Regional Director appointed by Tom Dean, Chairman of the Board for EPT, a long time Dean, at Long Beach State who knew Jim from his work there. Jim became Chair of the University Academic Senate, a first for a Design and Industry faculty member, he Chaired the University Faculty/Staff Club, and other school/university committees. Jim also developed the Bachelor of Science in Technology degree program, when he arrived on campus in 1985, working in conjunction with Dr. Wan-Lee Cheng, Department Chair and other faculty. Jim was a Visiting Professor at Chung Yuan Chrisitan University for seversal Summer Sessions, where he taught Engineering Materials.

Nathan Hare, Lecturer and first chair of Black, now Africana Studies in 1968 — first such program in the U.S., died June 10 at age 91.

CeCe landoli, Professor Emeritus in Design and Industry from 1990 to 2007, died July 10 at 76 with her husband, son and beloved sister at her side. Dr. landoli dedicated 26 years of outstanding academic service in Higher Education, including 15 years as a Professor in the School of Design, formerly Design and Industry, two years as the DAI Department Chair, two years as an Assessment Coordinator at SFSU, and as Research Manager for the Center for Public Policy Research at UC Davis.



Sandra Luft was born Sandra Rudnick in Los Angeles on July 22, 1934. Sandra, known in her first two decades as Sunny, discovered young her love of books and used to crawl under her bed to read. After graduating from Los Angeles High, she worked her way through an undergraduate degree at UC Berkeley, graduating in 1956 with a double major in Philosophy and English Literature. She went on to Brandeis University, receiving her Ph.D in the History of Ideas (1962). In 1962 she was hired by the interdisciplinary Department of Humanities at what was then San Francisco State College, where she taught for 55 years.

When she retired in 2017 at the age of 83, hers was the longest teaching tenure of anyone in the history of SFSU. An early postmodern thinker, her teaching and research emphasized the work of Nietzsche, Heidegger, and Arendt. It was a life-long passion for 18th century Italian philosopher Giambattista Vico that really defined her scholarship, and about whom she published a book, *Vico's Uncanny Humanism: Between Modern and Postmodern* in 2003.

Sandra had a stroke in 2021 and went to live with her daughter in Seattle. She died on July 13, 2024, 9 days before her 90th birthday. She is survived by her two children, Rachel E. Luft and Josh Luft.

William J. "Bill" Mason passed away on July 15th in San Francisco at the age of 98.

Bill was in the first graduating class at Abraham Lincoln High School where he met his wife, Janice; they were married for 74 years. Bill served in the Navy during World War II and the Korean War.

Bill earned a BA degree in business administration from Cal Berkeley, a General Secondary Teaching Credential and a Master's degree from San Francisco State University, and a Doctor of Philosophy degree in Economics from the University of Iowa. Bill and Janice came back to San Francisco and he became a beloved economics professor at SFSU from 1958 to 1994, retiring as an Emeritus but continuing to teach part time for many more years. Bill also served in administrative roles in the CSU system. He was the vice president of academic affairs at Stanislaus State and also at SFSU and then went on to be an assistant vice chancellor at the Chancellor's Office.

Bill unselfishly gave of himself and served as president of SFSU Alumni Association, president of the Lincoln Alumni Association, and president of our Retirement Association for five years from 1986 to 1991. He also volunteered for years to bring back to the U.S. and restore the last surviving WWII Landing Craft Ship, LCS 102, which is now a National Museum and memorial at Mare Island in Vallejo. Bill hosted a tour of the ship for Retirement Association members.

Bill was an extremely warm, positive, energetic and dynamic person with a great sense of humor. He is survived by his wife Janice, a long-time member of the University Women's Association. A memorial service and celebration of life will be held on October 12th at 10:30am at Bill's home church, West Portal Lutheran in San Francisco.

They are survived by two sons, John and Thomas, who are graduates of SFSU's Design & Industry department, and a daughter Janine.




